Scope of work

1. Demonstrate how to handle by-products and waste products
2. Define the extent to which the project will benefit the citizens of Bungoma
3. Undertake an overview of dimensions of chicken market
4. Establish a nucleus centre for indigenous poultry production from rural farmers
5. Identify the major stakeholders and communities in the area and create awareness on the importance of indigenous poultry farming.
6. Demonstrated social, economic impact and benefit of poultry value chain in Bungoma County and region
7. Demonstrate strategic local, regional and export of local poultry products
8. Capacity to put together enough professional, technical and managerial team to run the enterprise
9. Demonstrate financial ability of providing working capital for processing investment

Statement of qualification

The EOI responses must include details on:-

- a) Understanding of the assignment
- b) Proof of past experience in similar work or services and its broad strategy on the scope of work mentioned above
- c) Firm's human resource base and their specializations

- d) Evidence showing the technical and managerial capabilities of the firm in the field of assignment
- e) Engagements with local partners
- f) Financial capabilities and commitments
- g) Knowledge of effective management strategies

The interested eligible consulting firms must meet the following criteria:-

- a) Submit Company profile
- b) Submit Certificate of business registration/incorporation
- c) Submit Valid tax compliance certificate
- d) Demonstrate the ability and capacity to undertake the assignment; this should include evidence of experience in similar assignments with appropriate references, availability of qualified staff.
- e) List of at least three similar projects undertaken before, providing the name and contact address of the client, date(s) of execution and name(S) of the lead and associate firms
- f) List of at least three references of organizations your firm has offered similar services
